ROE #12 Annual Audit

During the first two weeks of September, Special Assistant Auditors for the Illinois Auditor General's Office were onsite in the Louisville Accounting Office to conduct the financial audit for FY12. The Auditor General's final report has yet to be released, but auditors have indicated to us that there were no findings and that ROE #12 continues to be in full compliance with all legal requirements and generally-accepted accounting practices and procedures.

Regional Board of School Trustees Update

Three current Trustee positions are up for re-election in the Consolidated Election on April 9, 2013. Current Board Chair, Paul Kermicle has opted not to run for re-election. Trustees Bill Staser and Josh Weger have indicated that they will run to retain their seats. Currently, we are aware of one candidate seeking Paul Kermicle's seat.
