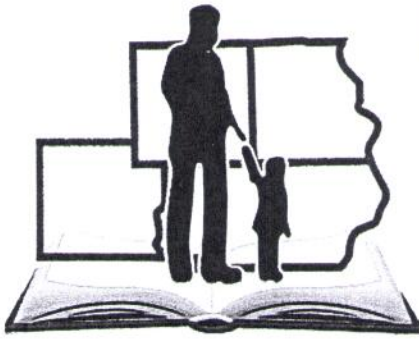
Based upon the board vote, the acceleration was approved with seven yes votes and zero no votes.
