Gene Allen made a motion to approve the minutes from the previous meeting, second by Josh Weger. Roll call vote to approve five yes votes (Staser, Farley, Allen, Weger, Janes) zero no votes.

Hearing Officer Monte Newlin presided over the petition hearing. He offered his appreciation to Judge Dunn and Judge Harrell for allowing the Regional Board to meet in the courtroom.

The petition to be heard was to detach territory from Clay City Community Unit School District #10 and annex same territory to North Clay Community Unit School District #25 submitted by Anthony and Jena Boose.

All present were given the opportunity to present testimony. The petitioners were represented by Attorney Melanie Pearce. Those presenting testimony at the hearing were Jena Boose and Cathy Croy, Clay City CUSD #10 Superintendent.

A motion to approve the petition was made by Josh Weger, seconded by Ron Janes. Using case law and school code, the Board considered testimony and the exhibits presented. Following consideration by the Board a roll call vote was

taken. Board members were instructed that a yes vote indicated they approved to grant the petition; a no vote indicated they did not approve to grant the petition.
