We're proud of you, Kathryn!!



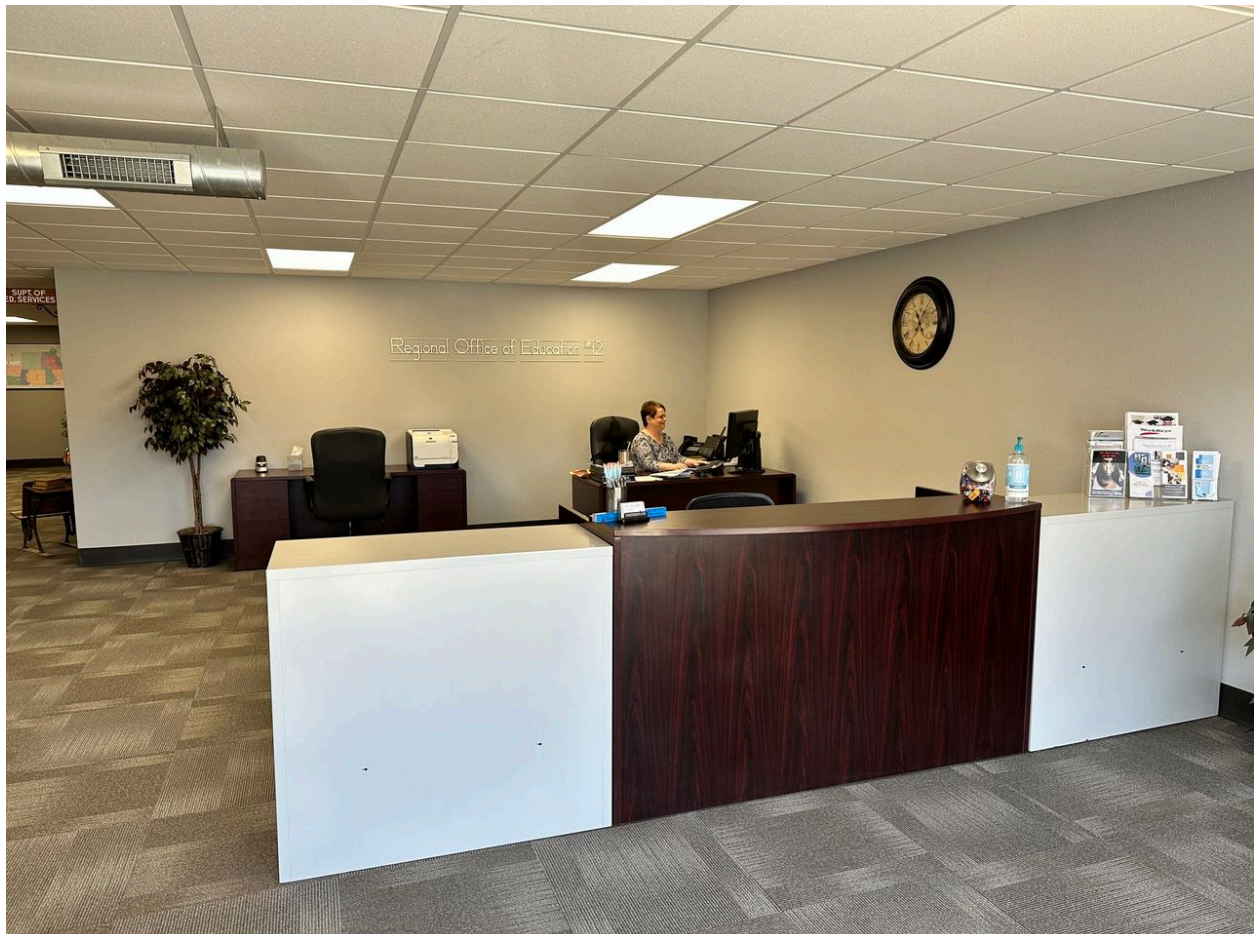
ROE 12 Issues Annual Report For 2021-2022
