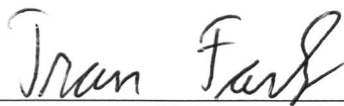

This is a summary statement as required by the Illinois School Code: A complete record of all matters and votes taken are contained in the transcript prepared by the Court Reporter.

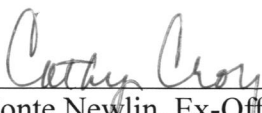
Julia New made a motion to adjourn the meeting, seconded by Gene Allen. All were in favor. None opposed. The meeting was adjourned at 8:10 p.m.
